This summary (which must have between 3 and 5 pages) or complete work must necessarily include:

- a) Title, full name of the authors and entity they represent, postal address, email, fax and telephone.
- b) Methodology: It is especially recommended to clearly state the objectives, methodology, sources of statistical information,

- Maximum Extension: 35 pages, including summary, tables, graphs and annexes.
- Edition: A4 page, single-spaced text, one column, justified, Arial type number 11, all margins of 2.5 cm.
